

Vaccine Rollout



Ongoing: staff and caregivers in long-term homes and retirement homes, health care workers and Indigenous adults.

New Provincial Direction



On February 14, the Province of Ontario issued a memo directing the sequencing of Phase 1 priority populations for vaccination.

Phase 1 now includes:



- Adults 80 years of age and older
- Additional direction and guidance on the prioritization of health care workers based on risk of exposure, patient populations served, and incidence of COVID-19 outbreaks

Phase 1 - Immediate Priority



Immediate Priority Groups

Status Update

Remaining residents:

- Long-term care homes
- High-risk retirement homes

Completed:

- 2nd doses to all 28 long-term care homes
- 1st doses to all 82 designated retirement homes

Remaining staff and essential caregivers:

- Long-term care homes
- High-risk retirement homes

In progress:

- 1st and 2nd doses
- TOH clinic and by mobile vaccination teams

Health Care Workers:

- “Highest priority”
- “Very high priority”

In progress:

- 1st and 2nd doses
- TOH clinic

Alternative Level Care patients

Urban Indigenous adults in higher risk communities

In progress:

- 1st doses
- Wabano Centre for Aboriginal Health
- Akausivik Inuit Family Health Team

Phase 1 - Next Priority



Priority Groups:

- Staff, residents and caregivers in retirement homes and other congregate care settings for seniors
- Priority health care workers
- All Indigenous adults
- Adult recipients of chronic home care
- Adults 80 years of age and older

The number and types of clinics that will open will depend on vaccine supply.

Strategies to complete these groups:

- Pop-up clinics in high-risk areas
- Launch community clinics
- Continue to operate hospital clinic (and potentially expand)

Adults 80 years of age and older & Adult recipients of chronic home care



- Given limited supply, immediate access to all residents in this population is not possible
- The City and OPH will undertake a phased approach beginning with pop-up clinics in communities experiencing higher rates of COVID-19 transmission
- The first pop-up clinic location will open on Friday, March 5 in a specific high-risk community
- Additional information on clinic locations and how to book an appointment will be available on Monday, March 1
- Vaccinations for the broader 80+ community **will begin later in March**, pending vaccine supply


Communication Strategy:

Older Adults

The City and OPH are developing a robust communication strategy for reaching adults aged 80+ to advise them on when and where they will be able to get vaccinated.

Tactics for communicating to this population will include:

- Public Service Announcements and earned media interviews
- Print advertising in daily and local community newspapers
- Radio advertising
- Targeted social media advertising
- Targeted outreach to appropriate stakeholders
- Diverse media outlets
- City's e-newsletter
- Communications through Members of Council



Community Clinic at St-Laurent Complex



Based on the new provincial direction, outreach is underway to enumerate various Phase 1 priority population groups:

- Highest Priority Health Care Workers:
 - All frontline hospital and acute care staff with COVID-19 patients and/or high-risk exposure to COVID-19 and all patient-facing health care workers involved in the COVID-19 response (**approx. 6,000 doses required**)
 - Medical first responders, which includes paramedics and firefighters providing medical first response (**3,112 doses required**)
 - Community health care workers serving specialized populations (**ongoing**)
- Congregate care settings for seniors (**ongoing**)
- Adults 80 years of age and older (**approx. 88,000 doses required**)

Community Clinics



- Up to 7 community clinics are being readied for when vaccine supply is increased
- Community clinics can immunize large numbers of people over a short period of time
- Once fully operational, clinics will operate from 8:00 a.m. to 10:00 p.m. seven days a week

Community clinics + 2 hospital clinics would have the capacity to provide **approximately 380,000 vaccines per month** - not including what can further be achieved with mobile vaccination teams, pop-up clinics, pharmacies and primary care settings

Mobile Vaccination Teams & Pop-up Clinics




Mobile vaccination teams will continue to be deployed as needed to reach targeted populations, including homeless and rural residents.

Pop-up clinics are set up at a site for multiple days, but are not permanent. They will be located in neighbourhoods experiencing higher rates of COVID-19 transmission.



Includes paramedics, public health, community physicians, pharmacists and hospital staff

Dependencies



- Vaccine supply will determine the number and types of clinics that will open (community vs. pop-up) and how quickly specific priority groups will have access to book appointments.

- Province is preparing to launch a booking system, which will be critical to operate the vaccination clinics.

Provincial Phases

Phase 1

December 2020 to March 2021

- Long-term care homes
- Retirement homes
- Congregate settings for seniors
- Alternate Level Care Patients
- Health care workers*
- Indigenous adults
- Adults 80 years of age and older
- Adult recipients of chronic home care

*Ministry of Health's Guidance for Prioritization

Phase 2

April to July 2021

- Older adults
- Residents and workers in high-risk congregate settings (ex: shelters, community living)
- Frontline essential workers, education workers and the food processing industry
- Individuals with high-risk chronic conditions and their caregivers
- Others facing barriers related to the determinants of health across Ontario who are at greater COVID-19 risk

More provincial guidance to follow

Phase 3

August 2021 and beyond

- Remaining Ontarians who wish to be vaccinated
